FROM THE PRINCIPAL

Dear Parents, Friends, Staff and Students of Caroline Chisholm College,

Welcome to the 2015 school year!

Last week's gospel from Mark saw Jesus in the synagogue healing a man possessed by a demon. While most of the story was concerned with the casting out of the demon, what is most striking (and relevant to us as an educational community) was the first two verses of the gospel: "They went to Capernaum; and when the sabbath came, he entered the synagogue and taught. They were astounded at his teaching, for he taught them as one having authority, and not as the scribes."

What set Jesus apart was the authority of his teaching. Indeed, the greatest significance of the healing of the possessed man was the authority Jesus displayed, so that the story becomes a proof of the initial verses and serves to illustrate that point. Caroline Chisholm College is place of quality teaching and learning where all students have the opportunity to be taught by committed teachers whose authority comes from their knowledge, enthusiasm and willingness to help all students succeed.

Let our prayer be that in 2015, staff and students work together sharing goals and embarking on a journey in which learning is the prime motivation, learning in the best and most holistic sense, where students learn skills and content but also learn about themselves and grow in wisdom as much as knowledge.

We were again honoured to have a number of students' Art works exhibited in the prestigious Art Express. Congratulations to **Scarlett Dunn, Rachel Gutteridge, Emily Kraljevic** and **Riley O'Connor** whose work will be exhibited in a number of galleries over the coming months.

Collectively the Year 12 students did very well:

- 100% of our students achieved a Band 4,5 or 6 in the following range of subjects Drama, Extension 1 English, Extension 2 English, Mathematics (2 unit), Music 1, Physics, Society & Culture, Textiles & Design and Visual Arts
- More than 90% achieved a band 4,5 or 6 in Business Studies, Community and Family Studies, Advanced English, Mathematics Extension 1, Studies of Religion I and Studies of Religion II.
- More than 80% achieved a band 4,5 or 6 in Legal Studies and PDHPE.
- A total of 62 Band 6 results were achieved along with 209 Band 5s across a range of subjects.

These are wonderful results so the bar continues to be set high for our current Year 12 students. The challenge they set applies, though, not just to the current Year 12s but to all the students in the college as final success in school is not just the result of what happens in the last year of schooling but is a reflection of all the learning that has taken place over six years.

Learning Goals for 2015

This year we will continue to use as our mantra to sum up our learning focus at the college the 5As – All students /All teachers /Always /Actively engaged in /Authentic deep learning. This became something all staff and students could readily recite last year and in 2015 we will continue to put this mantra into action as students learn how to be the best students they can be.

We will also have a focus on both realistic and achievable goal setting and the development of a positive approach to learning in which students challenge themselves to take further steps in their learning, under the guidance of their teachers. On page XV of the student diary there is an explanation of the goal setting strategy students will be asked to use by their teachers. Known as SMART goals, the acronym stands for goals that are Specific, Measurable, Attainable, Realistic and Timely. In terms of taking a positive approach to learning challenges, we will encourage students to say not "I don't know this" or "I can't do this" but, rather, to say "I don't know this ... yet" or "I can't do this ... yet".



New teachers

We welcome to the college community four new teachers. **Mrs Liesel Simpson** has joined the staff permanently and will be teaching Science. She is also the new 1 point Science Leader of Learning. **Mrs Rebecca Zammit** has also joined the staff permanently and will be teaching Mathematics. **Mrs Michelle Marelic** and **Mrs Robyn Wilson** will be here for the remainder of the year taking maternity leave positions and will also be teaching Mathematics.

May Jesus who grew in strength and wisdom, be with us all as we begin this year's learning journey.

FROM THE ASSISTANT PRINCIPAL

I'd like to welcome all the students and parents back for the year. I need to start the year by giving some generic information that I need to say at this time each year so there is no later confusion. While most of this information is similar to last year, I would ask all parents to read it carefully, as it is very important information and there are a few slight changes from previous years.

Vaccinations

Vaccinations for Years 7 will occur this year. Year 7 students will have three vaccinations, covering HPV, hepatitis B and chickenpox. The first vaccination for Year 7 students will be on **Wednesday 11 February**. Students in Years 7 received a permission form last Friday. I would ask that they be returned by this Thursday 5 February. They can come by the day of the vaccinations but we would prefer them before that for organisational purposes. It is important that students come to school on the day, even if they are a little unwell, as long as they don't have a fever. If they are unwell it is possible for them to be brought to school for the vaccine then go home. Vaccinations start at around 9.00 am. The other dates for Year 7 vaccinations are Wednesday 22 April and Wednesday 19 August. As some of the vaccinations have two or three doses, it is important for students to be at school for all the vaccination days.

There will also be vaccinations offered to Years 11 and 12 students on **Wednesday 11 February**. These are single boosters for measles-mumps-rubella (MMR). Many students will have already had these boosters. Any Years 11 or 12 students who need to get these vaccinations need to bring their permission note back by Thursday 5 February. This is the only vaccination for these students, although they can have their booster at one of the other Year 7 days if they miss next week.

Uniform

As usual, I am impressed by the appearance of the students at the start of the year and I'd like to thank the students and the parents for their support. We are a uniform school and it is the strong wish of the parent body that we enforce our uniform requirements. All students and parents, on enrolling at the college, also signed an agreement to abide by the college's uniform expectations.

If you are ever in any doubt if an item conforms to the college expectations, particularly if there is a cost involved, such as school shoes, please check with me or your daughter's Year Leader. The college uniform requirements are clearly spelt out in the student diaries and on the website. While the vast majority of students adhere really well to the expectations, some students push the limits. Three particular areas we will continue to enforce strongly are that the skirts must reach the bottom of the knees and that there are to be no piercings other than up to 2 in each ear (and no expanders – only simple studs or sleepers). In particular, there is to be no jewellery in noses or lips – including plastic studs – and that nail polish rules are followed. This has always been the college policy. Students with unacceptable jewellery or nail art or non-compliant nail polish will be asked to remove it immediately. (The rules for nail polish for senior and junior students can be found in the college diary.) Students are also reminded that the only neck wear allowed is a simple chain and cross.

All students from Years 7-12 must have the College backpack. Students in Years 7-9 must use the backpack each day, although they may use the blue tote bags with the college name for **additional** equipment. Only students in Years 10-12 may, if they only have a few books to bring on a particular day, bring the blue college carry bag only. Please note, though, that the carry bags are not designed for carrying substantial loads, either in terms of their durability or their ergonomics.

Students should have all their equipment including uniform items, clearly labelled. Students at the College are very honest and many lost items are handed in. It is very frustrating when the owner cannot be traced because there is no name on the item.

All students in Years 7-9 are required to have their hair tied back. Senior students, only, may have their hair out, but they must tie in back in classes with WHS requirements.

Any parent whose daughter has a problem meeting the uniform requirements immediately needs to contact her Year Leader or me to talk over the issues. Where there is an issue of genuine hardship and a uniform item cannot be purchased, parents and carers are asked to contact **Mrs Leask** or me, confidentially.

Caroline Chisholm Day

Students will be receiving information about Caroline Chisholm Day closer to the event but as this is the last newsletter until the day itself, I would like to draw parents' attention to a few matters:

- This is a significant college event and all students are expected to attend. Absences from this event will be noted on the semester report.
- The day consists of a full college mass at Padre Pio church followed by a fun afternoon, with games, rides and food.
- Students who wish to use the professional rides can buy a wristband for \$20. There are many other activities which are free or have a small cost which goes towards Project Compassion.
- Students are to wear their full uniform to the church. They can change into mufti on their return to school and go home in mufti.
- Students who do not attend the mass will not be allowed to take part on the afternoon fun activities. Students who come to school after the mass will be supervised in the library for the remainder of the day.
- The activities are for current Caroline Chisholm students only. No relations, friends or ex-students are allowed.
- Students can bring their own food, order from the canteen as usual or take their luck with other hot food stalls. Students will not be allowed to order food in or have take-away food dropped off to them.

Parent/Student Contact During the Day

As students should not have mobile phones on in class time, I would ask that any communication between parents and daughters happen in break time. I understand that there may be times when simple messages regarding domestic arrangements are sent this way.

However, in the case of a student needing to leave school unexpectedly or a potentially upsetting message needing to be conveyed, I would ask parents to use the school office as the channel of communication. If you need to take your daughter from school unexpectedly, please contact the school rather than your daughter directly. Similarly, if a girl becomes ill during the day she should notify her class teacher who will send her to the sick bay. The office staff will contact the parent and organise for the girl to speak to the parent if this is necessary and make arrangements for her to be picked up. Girls should not be contacting parents directly to ask to be picked up when they are ill. It is part of our duty of care that we are informed immediately a student feels unwell or needs to go home. We need to liaise with parents to make the best arrangements for the student's welfare.

Absences

- If a student is away from school, she must provide an acceptable **written explanation** signed by her parent or carer or a doctor's certificate within five school days (one week) of her return to school after absence.
- If a note is not returned by that date she will officially be recorded as "Absence is not explained or justified". Even if a note subsequently comes in, the official recording will remain "Absence is not explained or justified" and appear that way on the semester report, although the note will be stored in the student's file.
- Parents need to apply for leave from the principal if their daughter will be absent for more than two days (other than for illness).
- If a student is not in a homeroom at 8.23 am she will be marked absent. Students arriving after this time must sign in at the front office and have their late note signed by a parent or carer.

Please note that we are not able to send SMS messages notifying parents of a student's absence at this stage. Catholic Education Office Diocese of Parramatta has moved all schools to a central roll taking program and the facility to send SMS messages is still being developed. Parents and carers will be informed when this facility commences. *This also means that at this stage parents cannot explain a student's absence by a text message, as they could previously. Until the SMS facility is operating, all justifications for absence must be on a written note given to the homeroom teacher within five school days of the absence.*

Lockers

All students are provided with locker access, at no cost, unlike the case in some schools. Due to reconfigurations to the buildings, there is no longer room for a locker for each student. There are plans to purchase new lockers but it will require the building of structures to house them and there is no timeline at this stage. Years 10, 11 and 12 students share lockers. At this stage, Years 7-9 and half Year 10 students (to swap in semester 2) still have an individual locker. This is a privilege which comes with a few expectations. The first is that each student provides a secure lock for the locker. Students will not be allowed to use a locker if they do not provide a lock. Their items and school bags will be stored at the front office and they will have to go the office each time they need something.

Locks should be adequate for the job. Many cheap locks purchased by students are not secure and can easily be opened by other keys. There are a significant number of students who do not have locks on their lockers, yet use them to store items of value. We cannot guarantee the safekeeping of any item in a locker, even if it does have a lock on it. Lockers are

primarily designed for the storage of books and such, not as secure places to store valuables. Items of value, such as wallets, iPads, and phones (switched off) should generally be kept on the student's person. Furthermore, if there was no lock, the loss of an item from a locker will not be investigated. It is recommended that large amounts of money are brought to school by parents, not students. If a student has an item of value which must be brought to school, it should be left in the office for safe keeping.

Care for the environment

As part of our collective responsibility for the College environment, students will from time to time be asked to help pick up rubbish. Even as I pick up rubbish which is not mine, I would expect a student to co-operate with a staff member when asked to pick up rubbish, even if it was not theirs. Students have access to plastic gloves where this is appropriate or necessary.


Detentions

While relatively few students receive afternoon detentions, detentions are an important part of the college student management structure. All students and parents, on enrolling at the college, signed an agreement to abide by and support the college's student management policies, including possible afternoon detentions. The normal detention is for one hour. This may be for a serious offence or for an accumulation of 6 diary warnings for minor infringements. (Students receive a lunch detention after 3 warnings.) Any student who does not attend a scheduled afternoon detention without a valid reason will receive a two hour detention at the next available opportunity. This will comprise a one hour detention for the original offence and an additional hour for failing to attend without a reason. Notice of afternoon detentions is always posted to the parent/carer and requires a signed response. Please note that after school detentions will be held on **Wednesdays** (from 2.45 pm to 3.45 pm.).

Traffic Arrangements

A drop off zone on The Lakes Drive enables students to be dropped off in the morning and picked up in the afternoon outside the College gates. Due to the high pedestrian and bus activity in the mornings and afternoons **parents are not to enter the college grounds to drop off or pick up their daughters at these times.** There is **no access for non-staff vehicles** into the College grounds between 8.00am and 8.30 am or between 2.30pm and 3.00pm. Vehicles already on the premises may not exit between 2.30pm and 3.00pm.

Parents and students are advised that the speed hump outside the front western gate is not a pedestrian crossing. There is a pedestrian crossing and safety zone for crossing near the roundabout. Students are to enter the college grounds only through the pedestrian gate, not either of the vehicular entrances. The rear gate of the College is opened for pedestrian access only in the afternoon for students walking home and should not be a pick up point for vehicles.

FROM THE LEADER OF RELIGIOUS EDUCATION

OUR CATHOLIC FAITH

What is this thing called prayer?

As a Catholic Community we pray in lots of different ways and at many different times and places. We generally start our formal prayers with the Sign of the Cross. This is a gesture made when you move your fingers from your forehead to your heart and then to each shoulder. The action is accompanied by the words "In the name of the Father, the Son and the Holy Spirit." This action reminds us of one of our core beliefs- the belief in the Trinitarian nature of God. We believe that there is one God, and that God

can be experienced in the three persons of God- God the Father, God the Son and God the Holy Spirit.

Prayer includes personal prayer as well as public or communal prayer. We pray together as community because God calls us to be together, to be a community of God's people. To be Church.

There are many different types of prayer celebrations: the sacraments (Baptism, Eucharist or Mass, Reconciliation, Marriage, Ordination), liturgy of the hours (prayer said at special times of the day when we use psalms and prayers to thank and praise God), meditation (which may include a structured reflection on scripture passages called Lectio Divina) and the praying of formal prayers such as the rosary.

At Caroline Chisholm College we start each day with homeroom prayer. This prayer is a time to reflect on scripture, pray for special intentions and building a sense of community by praying for each other the needs of the world.

The traditional prayers of the Catholic Church are included in our student diary. These prayers include The Lord's Prayer, The Hail Mary, The Glory Be and The Nicene Creed and The Angelus. At Caroline Chisholm College the Angelus is prayed everyday around 12 o'clock. It is a prayer dedicated to Mary, the Mother of God.

The Angelus

The Angel of the Lord declared unto Mary.

And she conceived of the Holy Spirit.

Hail Mary, full of grace, The Lord is with thee. Blessed art thou among women and Blessed is the fruit of thy womb, Jesus.

Holy Mary, Mother of God,

Be it done unto me according to thy word. (Hail Mary...)

And the Word was made Flesh.

And dwelt among us. (Hail Mary...)

Year 7-12 Formal Assessment Policy and Procedures

The updated College Assessment Policy is now available for viewing on the College website under News and Events, School Notes, Whole School Notes. Here you can find the procedures that must be followed if your daughter is absent for a formal assessment task or examination and the steps that need to be followed to avoid a consequence.

All Assessment Handbooks and Calendars can also be accessed under School Notes on the website. Simply click the Year Level your daughter is in to access this information. Students have been asked to download a copy of the handbook and calendar to their technological device and have been asked to familiarise themselves with the policy.

At the College Assembly and various Year Assemblies last week, I had the opportunity to speak to the students about the new College Assessment Policy that takes effect as of this term. Posters have been placed around all classrooms and the Library to remind students and teachers of the expectations.

There is a copy of the Year 7-12 College Assessment Summary Chart included in this newsletter. I ask everyone to place a copy of this in a prominent place in your home and that you take the opportunity to speak to your daughter/s about the expectations.

Students in Years 8-10 should still be using their iPads in all classes. A reminder that all devices are to be fully charged the night before and brought to school ready for learning purposes.

Year 7-10 Jacaranda Textbook Packages

Students in Year 7 should now be able to access their textbooks as the cost of these was included in school fees. Families in Years 8-10 who have not yet finalised their payment for the bundle must do so by **Friday 6 February**. After this time students will lose access to their textbooks. All students are issued with an Assessment Handbook and Calendar at the start of the year via the College Website and Learning@CCC (Moodle). These documents are to be downloaded onto an electronic device for easy access.

All students will receive a Formal Assessment/Exam Notification Sheet at least TWO weeks before the due date of the task.

In-class formal assessment tasks or exams will be completed on the day you return or at the next available opportunity. The relevant KLA or Year Leader will make this decision.

ROLE OF THE SCHOOL COUNSELLOR

Firstly, welcome back to all our students returning in 2015 and all our new students commencing at Caroline Chisholm College in Year 7 and other grades.

I wanted to take the opportunity to explain the school counsellor role here at Caroline Chisholm College and how I may be able to offer assistance and support to you or your young person.

Aside from the occasional off-site meeting, I am generally available from 8am to 4pm each day. On average, I would see about six students each day who have self-referred, or who have been referred by their teachers or parents. Students submit requests to see the counsellor by filling in the form on Moodle under 'Student Wellbeing' – 'Student Counsellor Referral'. After the referral is submitted the student will either receive an appointment slip in their homeroom folder in the following days, or a runner will be sent for them.

Students choose to see a school counsellor about a wide range of issues, including study skills and time management strategies, friendship and relationship difficulties, and strategies to manage stress, anxiety and depression. I can offer assessment, strategies discussion, short-term counselling, and referral to external agencies where necessary. In the school counsellor role I need to be accessible to all students within the school, so I am unable to offer longer-term therapeutic counselling. If I believe that the student would benefit from more intensive counselling I recommend this to the student and/or their parents and can discuss a range of options.

Most students do not require parent permission to make an appointment with the school counsellor. However, given the age and developmental stage of the young person it may be necessary to contact parents about a referral. Other limits to confidentiality are based on risk of harm and mandatory reporting requirements. This is discussed with the young person from the onset so that they are very clear about this. In addition, it may be that some issues are better managed with the support of parents and/or teachers and this would be discussed and such consent encouraged with the young person. I also welcome contact from external professionals who may be involved with the young person as this allows us to coordinate how to best support the student at school.

I am always happy to provide consultation and discussion with parents on issues that are impacting on their young person. Due to the regularity of appointments it can sometimes be difficult for me to take calls during school hours. However, there is a voice message facility available or you can leave a message with our administration staff and I will return your call as promptly as possible. Please let the front office know, however, if the matter you need to speak about has a degree of urgency so that I can speak with you as soon as possible. Similarly, it is recommended that you make an appointment if a meeting is desired so that I can ensure that I am available. I endeavour to provide information each fortnight through the school newsletter and welcome any suggestions for topics that may be of interest and support to you.
